

**ARTICLES OF INCORPORATION  
OF  
FLATHEAD AREA YOUNG PROFESSIONALS  
TO THE SECRETARY OF STATE OF THE STATE OF MONTANA:**

The undersigned, acting as incorporators of a corporation pursuant to Section 35-2-213 of the Montana Code Annotated, adopt the following Articles of Incorporation:

**I**

The name of the corporation is **Flathead Area Young Professionals**. This corporation is incorporated pursuant to Section 35-2-213 of the Montana Code Annotated as a mutual benefit corporation.

**II**

The period of duration of the corporation is perpetual.

**III**

The purpose of organizing the corporation is to

- 1) Attract, retain and engage young professionals in the Flathead Valley;
- 2) Provide events and opportunities for social networking, professional development and civic engagement to benefit and grow the young professionals in the Flathead Valley.

Notwithstanding any other provision of these Articles, the corporation shall not perform any activities not permitted to be performed by a corporation exempt from federal income tax pursuant to the Internal Revenue Code.

**IV**

This Corporation is not organized for pecuniary profit and will have members. The qualifications for members and the manner of their admissions shall be regulated by the by-laws.

**V**

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

## VI

The qualifications for Directors of the Board and the manner of their election shall be regulated by the by-laws. The initial Board of Directors shall consist of no fewer than eight (8) and no more than twelve (12). The names and addresses of the initial Board of Directors are as follows:

## **VIII**

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to a qualified tax exempt organization. Distribution of assets will be subject to majority vote of Directors.

## **IX**

These Articles of Incorporation may be altered, amended or repealed by a majority vote of the Board at any regular or special meeting. The proposed amendments shall be emailed to the Board for their consideration at least five (5) days in advance of the meeting.


